

MONARCH TAKES FLIGHT

Monarch, CGLA's software to aid in the sealing and expungement of client arrest records, launched in January of last year and has since helped our organization assist hundreds of people in creating lives free from the stigma of a criminal record. In the year since it launched, this new software has been awaiting a new logo, and while the CGLA team is good at many things, graphic design is not high on the list. CGLA enlisted the help of pro bono volunteer Jasmine Attanasio, a senior user experience designer with the private plane company NetJets, to help create a Monarch logo that would reflect the vital work that we do.

Jasmine was first introduced to CGLA at the organization's annual pro bono volunteer recognition event held at their 6 S Clark office this past November. She attended with her aunt Nicole Allen, a fellow pro bono volunteer lawyer and E-Discovery Of Counsel at Kilpatrick Townsend & Stockton LLP.

It was there that Jasmine toured CGLA's Art and Archives exhibition that celebrates 50 years of CGLA's history and contributions to the legal aid community. Inspired by what she had learned, Jasmine began to wonder how she might contribute her skills to the work of CGLA.

She quickly became connected with our managing attorney Steve Fus and our director of support programs Cynthia Cornelius. A user experience designer by trade, Jasmine didn't fit CGLA's typical pro bono profile. She did however have experience working with Safer Foundation, a similarly aligned non-profit that provides re-entry services to returning citizens, and felt moved by CGLA's mission to contribute her own skills.

Cynthia and Steve had recently launched Monarch, a software that streamlines and automates certain aspects of the expungement and sealing research and drafting process. Monarch needed a new logo to bring it into the CGLA fold and Jasmine's experience as a designer made her a perfect fit for the opportunity.

Typically, the process of sealing or expunging a client's record requires collecting information from an individual's Record of Arrests and Prosecutions (RAP sheet) as well as a criminal history transcript that contains a list of arrests that happened anywhere in the state of Illinois. A petitioner must collect the date and booking number of an arrest, an IR number that corresponds to an individual's fingerprints, the name of the arresting agency, the types of charges, and the dispositions of each charge. If an arrest resulted in a court case, this information must then be checked against court documents. In other words, a whole lot of paperwork.

Monarch automates the collection of data from court documents related to an individual's arrest, making it easier for CGLA's attorney's to determine if an individual is eligible for expungement or sealing for a given arrest.

From there it's as easy as clicking a button. Monarch generates a petition from the available information, something individuals would previously have had to do by hand, leading to a dramatic increase in the productivity of the expungement process.

The expungement process allows CGLA's clients to be eligible for jobs, housing, and government assistance, allowing for a transformation in their daily lives. It was this transformation that inspired the name Monarch, chosen by Cynthia to reflect how butterflies change and grow over their lifetime. The monarch butterfly is also the state insect of Illinois.

For the software's logo, Jasmine wanted a design that would reflect the story of the butterfly and created a simple drawing of a monarch that could be paired alongside the name of the software. After trying out several different fonts and colors, the team settled on a sloping font in CGLA's iconic dark blue, Jasmine's butterfly resting on top of the "h" of "Monarch" as if landing on a flower. "Creating New Beginnings," was added as the tagline.

"It's been a great experience," said Jasmine of working with the CGLA team. "It's very nice to know that they also appreciate volunteers who aren't well versed legally, because that's definitely not my area of expertise. I think just them being as welcoming to a non lawyer professional was also very heartwarming. I was able to see how I could fit into their world as well."
