WHO WE ARE

Every day across Illinois, families and communities are harmed by the criminal legal system. Cabrini Green Legal Aid (CGLA) is here to help, providing legal services, social support and advocacy to knock down barriers. CGLA's focus on individuals and communities impacted by the criminal legal system, city and statewide, through both legal services and policy advocacy, is unique in the legal aid field.

We bring drive, commitment, and compassion to our work with adults and young people experiencing the intersection of poverty and criminalization. Through holistic legal services in criminal defense, family law and housing, and criminal records mitigation, we help individuals and families stay connected, maintain housing, and create pathways out of the criminal system and into economic stability.

CGLA was founded in 1973 to serve the residents of the Cabrini-Green housing project, and since that time, we have expanded to serve individuals across Chicago and Cook County, and communities statewide. Our deep Chicago roots and work across Illinois means that we have the standing, the reputation, and the relationships to support policy-making tables pushing for fairness and justice.

We have worked with coalitions and partnered with individuals directly impacted to help disrupt the cycle of criminalization and address the damage done to communities. Through our staff and partnerships, and with the aid of volunteers, our work serves 8,000 plus clients per year, as well as communities all over Illinois. With the support of our funders and donors, we are making a difference.
